We are registered in England and Scotland as a limited company (00536326). We are registered with the Information Commissioners Office (ICO) as data controllers (Z9600380).

In line with the Data Protection Legislation and this notice, we are the 'data controller'. This means that we are responsible for deciding how we hold and use your personal data. 2. What information we collect, use and why

We collect or use the following information to provide services and goods, including delivery:

We use a secure file transfer portal dataXchange to transfer customer data. Received files are encrypted at rest in a restricted area of our IT infrastructure. We do not accept any responsibility for the security of the data if dataXchange is not used for data transfer. Data is supplied to produce printed material and will be held within our IT infrastructure in line with agreed data retention periods. Following this it will be securely destroyed and/or returned to the customer.

- Your right to withdraw consent When we use consent as our lawful basis you have the right to withdraw your consent.
- You do not usually need to pay a fee to exercise your rights. If you make a request, we have one calendar month to respond to you.
